4 Voted, that Dea Saml Stowers, & his wife Stowers receive letters of dismission, to unite with the F.W. Baptist Church at Farmington.

5 Voted, that Dea J. Smith, & Bro Daniel Child be the delegates to next S.M. with the power of substitution.

Bro Sylvester Jones of Partridge (Licentiate) commenced preaching with the Madrid Ch. for the year to come, 1/4 of the time, the meetings to be held twice out of three times at the Brackett corner meeting house, the other third in Madrid, divided between the Gurham & Stowers school houses,

Wed. June 15th /59. After session by A. H. Morell, at the West Philip's meeting house, at 4 o'clock P.M. Miss Elvira Cook was received for baptism, by the Madrid Church, & immediately baptized,
